C112 Chairman's opening remarks

The Chairman welcomed members to the meeting and made the following announcement:

Tony and Pat McCarthy

The Council had been informed of the joint funeral service for Tony and Pat McCarthy to held at SS Peter and Michael RC Church on 23 January 2025.

Tony was elected as Chairman of the Council several times and as Chairman of the Finance and General Committee during his 35 years' service as a Parish Councillor until his retirement in May last year. For a time, Pat also served as a Parish Councillor, both working together for our community.

Tony will also be remembered by many for his service as a Borough Ward Councillor for Rixton and Woolston. He served as Chairman of the Development Management Committee, a demanding role in dealing with planning issues. On retiring from office he was appointed by the Borough Council as an Honorary Alderman.

The Council recorded their appreciation of the service given by them both to the community in Woolston and members stood in silence in respect of their memory.

C119 Budget and Parish Precept 2025/26

The Council considered a report of the Clerk on the Budget and Parish Precept for 2025/26. The report gave a summary of the estimated net expenditure for 2025/26 together with other financial provision to be made. The Council had agreed that the budget be prepared on a no growth basis (Minute C105(2) - 3 December 2024). The Council also received the Management Accounts for the quarterly periods 1 April to 31 December 2024. Information provided by the Borough Council on the Tax Base for 2025/26 was noted.

In determining the precept the Council had regard to additional financial pressures on the community in common with other areas to be met in the coming year: Resolved.

Councillor Tynan

 action had been taken with officers regarding incidents of flooding to the rear of properties on the western side of Poulton Crescent and on blocked main drains on Cliftonville Road.

Councillor Sheridan

- Community Initiative Funding the decision to remove funding was being reviewed.
- Caravan, Bridge Road land being landscaped.
- Highways England motorway slip road.

Matters raised with the Borough Council

- Borough Council review of road safety on Holes Lane, Hillock Lane and Gig Lane No further information to report.
- A57 Manchester Road notice of structural maintenance works

The Borough Council had provided information on structural maintenance works to be carried out on the A57 Manchester Road from east of Redwood Close to east of Riversdale (Minute C72(1) – 10 September 2024. The information plan had been sent to nearby residents and businesses and published on the Council's website. The scheme was to include the reconstruction of the existing pedestrian island on Weir Lane and constructing a new pedestrian island on Manchester Road just to the west of the junction with Weir Lane. Residents had made representations to the Council at the new pedestrian island not being constructed.

This matter had been raised with officers and a response had been made that what may have been seen marked up on site was a possible crossing point with a pedestrian/cycle island in relation to a proposed 'wider' scheme of improvements for pedestrians and cyclists in the local area by the Transport Planning Team, and was set out to explore whether or not the proposals would fit in the highway and what the issues might be, but has not gone ahead as part of the ongoing resurfacing scheme.

This response had been raised with the Transport Planning Team who had responded that the island on the western side of the Weir Lane junction was originally proposed to provide improved pedestrian and cycle access into Woolston Industrial Estate via the footpath link to Chesford Grange. Whilst this aspiration remains, implementation of the scheme had been deferred whilst further work was undertaken to investigate the interaction between the planned crossing point and the right turn lane for vehicles turning into Weir Lane. Unfortunately, there was insufficient width available in this location to provide an acceptable pedestrian island which could provide capacity for both pedestrians and cyclists. The aspiration to increase pedestrian and cycling accessibility in this location remained, but further work would need to be completed before a revised scheme on Manchester Road was proposed. The timescales associated with this were unknown at present. In the meantime, the signalised crossing facility was available for use further west along Manchester Road, between the Weir Lane and Redwood Close junctions.

 Holes Lane/Green Lane – installation of speed monitors – a proposal had been made for the Borough Council and parish councils to collaborate in the introduction of speed monitors on this route.

Resolved.

That

- 1. Borough Ward Councillors be asked to give their support to the scheme for a new pedestrian island on A57 Manchester Road;
- 2. Councillor Tynan be requested to contact the Borough Council regarding the proposal for speed monitors on Holes Lane/Green Lane.

The BLAA had offered to make a contribution of half the net cost of materials to assist in the ongoing maintenance work:
