#### **EA28 Minutes**

#### **EA29 Development adjacent to the Thelwall Viaduct**

The Committee noted a report on activity relating to works at the site.

#### EA30 Parish Path Warden scheme

Councillor Nowell reported and the Committee noted that:

Public Footpath 12 at Nicol Avenue was passable.

The footpath at Weir Lane alongside the River Mersey had re-opened from Weir Lane to Edward Gardens.

The siting of large stones, possibly to deter parking of vehicles had been carried out on the length of highway at the New Cut Canal lock entrance at Weir Lane. This had been reported to the Public Rights of Way Officer.

#### EA31 Hillock Lane Amenity Area – development of improvement scheme

The Committee gave consideration to the development of an improvement scheme for the amenity area:

That the Clerk circulate a form to all members for consideration at the October meeting to assist in the development of a scheme.

#### EA32 Hillock Lane Amenity Area – security of car park entrance

The Clerk reported on advice received from the Police Community Support Officer on options for measures to improve security of the entrance to the car park; no advice had been received to date from the Crime Prevention Officer. The Clerk reported that the Borough Council used both height barriers and lockable bollards:

- 2. the Clerk consult with the Chairman of the Finance and General Committee in the event of urgent action being required.
