MINUTES OF THE MEETING OF THE WOOLSTON PARISH COUNCIL HELD AT THE WOOLSTON NEIGHBOURHOOD HUB, HALL ROAD, WOOLSTON ON 7 SEPTEMBER 2022

<u>C46 Code of Conduct – declarations of interest</u> Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

There were no declarations of interest.

C47 Apologies for absence

Apologies for absence had been received from Councillors J Dixon, on business, M Pearce, through ill health, and AJ Hill were noted.

C48 Minutes of the previous meeting

Resolved,

That the minutes of the meeting held on 13 July 2022 be taken as read and signed as a correct record subject to the deletion in Minute C44 Business raised by Council Members – Warrington Worldwide article – report on planning objection of the sentence, "The article had been amended from that appearing in the Warrington Guardian on the same topic relating to the objections made by the council to this application".

C49 Matters of report from previous minutes - Borough Council business

Further to Minute C36 – 13 July 2022, Councillor McCarthy considered that the introduction of an Action List for members to track matters reported to the Borough Council and other matters was of even greater importance given the impending resignation of Councillor Dixon. It was noted that a draft format of an Action List was to be considered at the meeting.

C50 Policing of Woolston – community liaison report

PCSO Roberts attended the meeting to present a report on the policing of Woolston for August 2022. It was noted that PC Taylor had been appointed as the Neighbourhood Officer for Woolston.

The youth zone in Warrington town centre had opened in July. For teenagers living on the outer areas of Warrington such as Woolston they may not be able to utilise this great facility if they do not have an adult to transport them to/from the location. Local buses tend to not run across some of these outer areas after 6-7pm. The police had been suggested that the parish council might want to consider/discuss whether they could support a youth zone bus service – limited stops (perhaps using the school bus locations?), where the teenagers pay say 50p/£1 each way to get them to/from the youth zone for areas like Warrington East

The Council was asked to consider if this was a feasible idea, to be operated with other parish councils by holding discussions between them and/or bus operators in Warrington. Members asked for information on the supply of No Canvasser No Caller notices for issue to residents. It was noted that these could be obtained through Warrington BC and at some community events. A comment was made on the attendance of police officers on motor bikes in Woolston Park. It was noted that this was part of "Operation Scrambler" referred to in the monthly report:

That the report be noted and consideration be given to the suggested support for use of the Youth Zone.

C51 Borough Council business

The Council considered the following reports:

Report from Councillor Dixon

1)Borough Councillor report.

I am pleased that the drains on Manchester Rd have been cleaned, as requested last meeting by Cllr McCarthy.

I am heavily involved in a dispute between two neighbours also, on Manchester Rd as to the use of buildings in the rear garden - I hope this will be resolved, following a Warrington BC investigation, in the next few weeks.

Residents have been concerned about the hatch markings being unclear near the new Sainsbury Store, so I am asking for these to be repainted.

The issue with Abingdon Avenue remains ongoing - a meeting will take place soon to reexamine the partially resurfaced pavement and to allay some of the anger raised by residents. I had a meeting myself recently to help resolve the situation. Additionally, there was a damaged access point on Vaudrey Drive which was covered by an orange cone: I had asked for this to be repaired, but it turned out the responsibility was British Telecom and Warrington BC had contacted them - this has now been resolved. Having met with residents on Alder Lane, I have asked for part of the pavement, which is badly worn away, to be resurfaced.

As requested last meeting, I have contacted the relevant people and, hopefully, a speed wire will be put down to gather data on speeds on Gig Lane soon.

Another issue is the request for a feasibility study for new lighting on Weir Lane, which was promised last year. This has not yet been responded to and I have asked for a progress update - it is dark and dangerous during the winter months, especially for children walking to and from the bus stop, so I feel lights will be beneficial.

The tree situation on Bowfell Grove I have already emailed about, but I suspect that will be an on-going issue now that permission was granted for one house to fell the trees and replace them, under strict conditions.

I had a meeting with an officer in Poulton Crescent and he has promised action to reduce the hedge and tidy the park up in September, but I understand it has not yet happened this has not been done for several years so I am pleased with the outcome.

There is an 'abandoned' house, recently boarded, at the end of Weir Lane. There is an ongoing dispute, as I understand it, between the owner and Peel Ports as to land ownership and other connected issues, hence it is boarded. This will need to play itself out and there is

little that can be done from a Parish or Borough perspective, unless issues arise with rats or other social problems.

Finally, there will be a full council meeting in later September, following the summer recess.

2) Prospective Resignation

As some of you know, after much thought and deliberation, I have accepted a new position teaching in St Louis, Missouri, USA. This was an incredibly difficult decision to make, not only due to my responsibilities and sense of commitment as a Borough & Parish Councillor, but also for family and personal connections in the UK. Nevertheless, I am now in my new position and enjoying it.

After several discussions with Warrington BC Chief Executive Steven Broomhead, and other relevant officers, as well as party leadership, it was decided to wait until now to communicate this more publicly. Whilst I agree with the rational, I was, and am, sorry not to have been able to communicate this in person.

The date of my resignation for both Woolston Parish, Rixton & Glazebrook Parish and Warrington Borough Council, is likely to take immediate effect from the end of November 2022. The reason for this delay is to allow for the Grappenhall by-elections to take place, scheduled for the end of September, and then to allow for the relevant parties and interested groups to recover and prepare adequately, hopefully aiding local democratic engagement in the process. The second reason is to allow certain casework that I am currently working on to be resolved in a timely manner. It would be best if new casework be directed to Cllr Hill or Eastty in order to action from now on in.

I will still be working remotely on casework but will need to send my apologies for the scheduled meetings until then. I will submit a Councillor report, but this will be limited due to my working remotely. I will not be drawing any allowance effective September 1st, as I do not personally feel it is appropriate. In order to minimise disruption to the parish and allow time for on-going projects to bed-in, such as the King's Academy outreach, it seems best to have the by-election on the same date for both parish and borough, thus dividing costs. If there is a change in the date, for whatever reason, the parish will be informed directly.

On a personal note, it has been a tremendous privilege and honour to serve both as a Parish and Borough Councillor for Rixton & Woolston. I have gained a huge amount of experience and many friendships and positives in the process. I am genuinely sorry to resign early, cause extra work and, above all, no longer to work directly with such committed and inspiring colleagues, especially on the parish. I will be keeping my property in Woolston and registered as an overseas voter, so I am cheering you all on for success in caring for the life of the community. I feel that lots of good projects are underway and that, despite it only being 18 months, lots of progress has been made, building on the excellent work inherited from previous Borough & Parish councillors. Thank you to the parish clerk, David, and to Maureen, and you all, for your wisdom, support and welcome - I think Woolston is a model parish in working collaboratively for the good of the area. I hope to see you at Christmas time, when I will be back in UK. I am also happy to be contacted on the published email address at any time and to answer any personal questions that may arise. Until then, I wish you all the very best for the future and look forward to reading about the excellent work ahead!

C52 Committee matters

(1) Environment and Amenities Committee

1. Parish Path Warden scheme - condition report

Councillor Nowell reported on matters relating to public footpaths and on issues that had been reported to the Borough Council:

- Nicol Avenue path obstructed by vegetation.
- New Cut towpath report on social media that path overgrown but no location stated. Increased use of the route by cyclists and users of electric powered bikes.
- Weir Lane adjacent to Lock House cars parking and obstructing the footpath.

Resolved.

That the report be noted.

2. <u>Development of "Old Billy" scheme</u>

Further to the report to the Council (Minute C39(1) 2. - 13 July 2022) the Clerk reported a response from the Borough Council on the implementation of the scheme. Support was given to the proposed signage subject to further discussions on the location of these on the towpath between Weir Lane and Paddington Bank and consideration of the results of consultation with the Poulton with Fearnhead parish council and the New Cut Heritage and Ecology Trail Group. The group worked in partnership with the Borough Council on works along the towpath and the adjacent open spaces. Consideration was given to the options for the supply and installation of the signage:

- approval be given to commission Warrington BC Environment Services to procure the supply and installation of the signage utilising their existing contractors subject to consideration of the cost of the works;
- 2. consultation with Poulton with Fearnhead PC and the New Cut Heritage and Ecology Trail Group be carried out when the final artwork has been received from Culture Warrington and the cost estimates are known.

(Councillor Banner declared a non-pecuniary interest by reason of being Chair of Culture Warrington)

3. Facilities for young people - progress report

Noted that no further action to report. (Minute C39(1) 3 – 13 July 2022).

4. A57 Manchester Road – planting in the highway verge - progress report

The Council reviewed the planting in the highway verge undertaken by the Borough Council. The display of flowers had not been as successful as hoped, probably because of the weather conditions during the summer:

5. Battery Lane allotment site - management matters

The Council noted that monthly inspections of all plots at the site were being held with the Battery Lane Allotment Association and action taken as required on issues identified.

Luckily the weather was pleasant during the morning. Just 6 of us today. Quite a lot was achieved. The usual litter picking, the new trough is now complete with dwarf chrysanthemums.
