C1 Code of Conduct – declarations of interest Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

No declarations were made at the opening of the meeting.

C2 Apologies for absence

The Council noted the apologies for absence from Councillor A Hill.

C3 Minutes of the previous meeting

Resolved.

That the minutes of the meeting held on 26 February 2020 be taken as read and confirmed as a correct record. The minutes, as approved, to be signed by the Chairman at the next physical meeting.

C4 Matters of report from the previous meeting – C103 Borough Council business

Councillor McCarthy reported and the Council noted that

- The appeal against refusal of Planning Application 2019/34391-11 Manchester Road had been allowed subject to conditions. Major construction work on the Sainsbury's local supermarket seemed unlikely this year.
- The trees in Redwood Close had been inspected and no work was needed at present.

C5 Borough Council business

Borough Councillors McCarthy and Wright reported, and the Council noted matters under consideration by the Borough Council relating to the parish and on issues that the Borough Ward members had acted on for residents including:

- Speeding vehicles along Riversdale and Battery Lane reported to police.
- Woolston Park and Dam Lane Shopping precinct regular patrols being carried out by police following reports of anti-social behaviour by youths.
- Number of residents requesting assistance resulting from the Coronavirus lockdown that had commenced on 23 March 2020. Advice had been given to contact the Safe and Well Service jointly operated by the Borough Council and Warrington Voluntary Action.
- Flooding within Croftside junction leaves blocking gully grating had been cleared.

- Footpath from Warren Lane to Hall Road shrubs to be cut back to clear the path.
 Majority the responsibility of Torus Housing; Borough Council to ensure that the route is included in the weeding program.
- Details were provided of a draft scheme to improve parking provision at Parksway.
 This would involve the removal of the paved island opposite the shops and the provision of 14 parking spaces. Consultation was to be held with those affected.
- Cliftonville Road, ownership of land under electricity pylon. Complaints had been received regarding the dumping of rubbish and the lack of maintenance of the grassed area beneath the pylon. Further attempts were being made to determine responsibility for the land and to the possibility of fencing the land.
- Complaint regarding a vehicle damaging a fence in Fitzwalter Road was being investigated.
- Complaint received regarding the operation of the Safe Storage premises on Manchester Road. Planning Officers had confirmed that the use was in accordance with the planning permission.
- Noted that major roadworks had been advertised on the A57 Manchester Road between the north and southbound junctions.
- No decision had been made in respect of the appeal against refusal of Planning Application 2019/34923 submitted by Mincrete for premises at Forward Works, Bridge Lane.
- Fly-tipping reported to the Borough Council.

C6 Committee matters

- Environment and Amenities Committee

– (1) Woolston Playing Fields and Hillock Lane Amenity area – application for siting of storage equipment

The Clerk reported that Woolston Rovers FC had made a further application for the siting of a storage facility on the playing fields. This followed notice to the Club of the award of grant aid for sports equipment and the resulting need for storage. The Borough Council had been asked to comment on the application in view of their development of a scheme for the playing fields:

- (2) Parish Path Warden scheme

The Council noted that the Parish Path Warden scheme across Warrington was informally suspended by mutual agreement with the Public Rights of Way Officer in late March 2020. This action was taken having regard to the guidance from the Government regarding the Covid 19 pandemic.

- (3) Complaint regarding littering - action by the Borough Council

The Clerk reported that a complaint regarding parking, littering and other issues in Parksway and Fitzwalter Road had been referred to the Borough Council using their website service. An acknowledgement had stated that the issues had been referred to the relevant officers to

investigate and reply. The Borough Ward Councillors reported that they had no knowledge of the complaints made by the resident prior to the matter being reported to the parish council:

- (5) attendance at meetings and council business during the Coronavirus pandemic

On 4 April 2020, the Government had brought The Local Authorities (Coronavirus) (Flexibility of Local Authority Meetings) (England) Regulations 2020 into force and this allowed local authorities to conduct meetings remotely until May 2021. This followed the decision of the Government to introduce Stay at Home guidance with effect from 23 March 2020. Guidance had been updated by the Government since that time to reflect the changing situation in England with Covid 19. Restrictions remained in force on holding meetings in public and the advice from the National Association of Local Councils was to hold remote meetings having regard to personal safety.

The Clerk reported on trials of various remote meeting platforms and that this had resulted in the selection of a Telephone Conference system as being the most suitable option. This followed a trial of the system with all members. The system was compliant with statutory regulations. A review of the system would be carried out following the meeting.

The Regulations had made no provision for suspending the provisions of the Local Government Act 1972 regarding attendance at meetings and consequently Councillors Creaghan and Maher had ceased to be members. It was noted that the Clerk had made both members aware of the situation. Notice of the casual vacancies would be given in consultation with the Returning Officer of the Borough Council. In the event that an election was requested paragraph 6(2) of the 2020 Regulations would apply and a poll would not be held to fill the casual vacancy; instead the vacancy would be filled at the ordinary election on 6 May 2021. If a poll was not requested, the provisions relating to filling a vacancy by cooption would apply:

- Criminal damage to vehicles Melford Court & Longbarn Lane 5x youths are under investigation in relation to these offences, awaiting CPS review
- Following spike in youth ASB and criminal damage issues, all Warrington East officers deployed to patrol Woolston Park & shops on our recent lates shift
- WBC Community Safety Team are conducting youth outreach work, commenced 29/6, across
 Warrington with Woolston included on their areas to patrol and engage with youngsters regarding behaviour
- Cannabis Farm located, evidence seized, farm dismantled on a Woolston industrial unit 05/06 A male from the GMP area arrested this week as part of the ongoing enquiries
- A red Corsa linked to suspected drug activity & nitrous oxide use on Woolston Park was seized with driver arrested 26/6 in another area of Warrington, following reports of similar activity
- Speed enforcement conducted 08/07 Hillock Lane during period of observation 70 vehicles seen in 20min, max speed 30mph
- Speed monitoring Weir Lane 9 vehicles in 10min. 1@ 25mph, 1@21, rest were below 20mph
- Speed monitoring Parksway 10 vehicles in 10min. Max 21mph
