MINUTES OF A MEETING OF THE WOOLSTON PARISH COUNCIL HELD AT THE WOOLSTON NEIGHBOURHOOD HUB, HALL ROAD, WOOLSTON ON 15 JANUARY 2020

No declarations were made at the opening of the meeting.

C85 Apologies for absence

The Council noted the apologies for absence from Councillors M Creaghan, A Hill, D Hill, M Pearce, B Maher and P Wright. The Chairman reported that the condolences of the Council had been sent to Councillor Pearce following her recent family bereavement. Members welcomed Councillor Banner following her recent illness.

C86 Minutes of the previous meeting

Resolved,

That the minutes of the meeting held on 27 November 2019 be taken as read and signed as a correct record.

C87 Woolston Weir Hydro scheme

The Council received a presentation from Ewan Campbell-Lendrum, Director H20 Power Ltd on the Woolston Weir Hydropower scheme. The timeline for the scheme was:

Detailed design and procurement October 2019 – January 2020

Site preparation (including cable)

Main construction

January – March 2020

March – September 2020

Commissioning October 2020

In total it was expected to take around 12 months to build the scheme, plus several months of minor works:

Months 1-3 Piling and use of heavy plant for excavation

Months 4-12 Turbine/fish pass installation, assembling turbine housing Months 12-16 Tree planting, commissioning tests and other minor works

The scheme was on a smaller scale to that previously reported to the Council. The main changes were an upgraded fish pass, reduced reserve flow, screw turbines "in line", H20 Power (Violet) Ltd and slight traffic reduction.

Members requested that consultation be carried out with residents affected by the scheme and the general public. Reference was made to the consultation process implemented by the Environment Agency with their recent flood defence scheme. Mr Campbell-Lendrum reported

that some consultation had been held with residents most affected by the scheme and there would be a wider consultation and information exercise about the works. In answer to points raised he reported that heavy goods vehicle traffic (HGV) would involve most disruption when the three turbine screws were delivered to the site. At other times the average HGV movements would be about three a week. The use of St Peters RC Church for an information event would be considered. No works were planned involving public rights of way but there may be some delays to users during works. Plans were in place to reduce any effect on local wildlife eg pruning/removal of trees. Planned working hours were 0800-1800 hours Monday to Friday. Operational noise from machinery at the completed weir was designed to be minimal. Visits to the completed weir scheme, eg by schools, would be available.

Resolved.

That the thanks of the Council be given to Mr Campbell-Lendrum for his presentation and the proposed ongoing consultation and information to residents and the public.

C90 Policing of Woolston – community liaison report

Borough Councillor McCarthy reported, and the Council noted matters under consideration by the Borough Council relating to the parish and on issues that the Borough Ward members had acted on for residents including:

- Maintenance to the grass verge on the south side of Manchester Road from Dam Lane to Riversdale to clear the growth from the fencing and the adjacent informal pathway.
- Representations to continue the street lighting on Weir Lane for its full length to the New Cut Canal.
- Noted the intention to provide sub-post office facilities at the AJ Convenience store, 534
 Manchester Road from 24 February 2020. This followed notice of the closure of the
 present Paddington Sub Post Office at Holes Lane in December 2019.

The Council heard representations from a resident at the poor state of the surface of the access road from Somerset Way to Woolston Park. It was known from previous consideration of matters relating to the road that there were issues relating to ownership and maintenance responsibility. Councillor McCarthy reported that he would raise this matter with the Borough Council.

Concern was also expressed by the resident, who was a volunteer for Woolston Rovers sports teams, at the flooding of a large area of Woolston Playing Fields. The Council was also asked for details of plans by the Borough Council that had been reported for a floodlit 4G sports area. Members responded that that the issue of flooding and the future development of the playing fields had been raised with the Borough Council earlier in the year. It was agreed that the Borough Council be asked to provide an update on plans for the playing fields, including remedying the flooding of the pitches.

C91 Committee reports and recommendations

Review of 2019 Show

It was agreed that the Show, the last annual Show to be held, had been very successful.

Points were noted to help in the organisation of future events in the park.

Future Events

Another Santa Dash would be held in December

The 2020 Easter Eggstravaganza will be held on Thursday. 16th April and an Egg Hunt will also be organized then. The event will run from 1.30 – 4 pm.

A Teddy Bears Picnic will be held on Saturday, May 30th. Further discussion will take place early in next year regarding the organisation of this.

A Fungal Identification Walk would be arranged around the park and a date would be requested, possibly in the Spring, with another in the Autumn.

Talks were also planned on Nettles with two further bat walks.

A Picnic on the Park event was to be held.

A Musical Evening will be arranged for Saturday, 4th July, with local schools invited to provide choirs.

A Talent Contest was suggested possibly to be held at Monks Social Club, with September being the preferred time.

A "What's On" leaflet was suggested to help promote the Group's activities, including Cafe Day dates.

A Bird Box Making Day would be arranged to take place in January or February, also involving the Young Friends Group. The boxes would then be sold to the general public.

Finance

Report submitted on the Show Account details of Income and Expenditure. £3,217.91 would be carried forward. Understood that a £400 bond paid to the Borough Council was to be reimbursed. It was agreed that the financial contribution from Woolston P C. would be used towards the hosting of smaller events on the park. Scout Group still had to be reimbursed for the hire of their marquee.

Next meeting to be held sometime in the New Year, details to be advised.

Public Rights of Way Forum – the meeting of the Forum scheduled for 12 December 2019 had been postponed until 13 February 2020.
