EA4 Development adjacent to the Thelwall Viaduct

EA5 Parish Path Warden Scheme

Councillor Nowell reported and the Committee noted the items reported to Borough Council Rights of Way officer and responses received:

- A report had been made to the Borough Council that the timber fence at Battery Lane had been broken;
- The gap between the gate and the fencing at the Weir Lane Flood Defence site had been filled;
- Giant Hogweed on Path 31 had been sprayed;
