MINUTES OF THE MEETING OF THE WOOLSTON PARISH COUNCIL HELD AT THE WOOLSTON CHURCH OF THE ASCENSION, WARREN LANE, WOOLSTON ON 8 SEPTEMBER 2021

C37 Chairman's opening remarks

The Chairman welcomed members and PCSO B Roberts to the meeting.

<u>C38 Code of Conduct – declarations of interest</u> Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

There were no declarations of interest.

C39 Apologies for absence

The Chairman reported further to Minute C25 – 23 June 2021, that Councillor Wright had been given medical advice not to attend public meetings at this time and submitted her apologies for absence. Councillor D Hill was on holiday and had submitted her apology for absence:

- 1. the best wishes of the Council be sent to Councillor Wright for a full recovery to good health and her apology for absence on medical grounds be accepted and the matter be reviewed, if necessary, at the next meeting of the Council;
- 2. the apologies for absence from other members be noted.

C40 Minutes of the previous meeting

Resolved,

That the minutes of the meeting held on 23 June 2021 be taken as read and signed as a correct record.

C41 Matters of report from previous minutes

There were no matters to report.

C42 Policing of Woolston - community liaison report

The Council received a report on the policing of Woolston for July and August 2021. together with comments from PCSO Roberts.

Councillor McCarthy reported further to Minute C35 23 June 2021, on major incident resulting from a fire at a domestic property on the A57 Manchester Road attended by the Cheshire Fire and Rescue Service. This had required the road to be closed by the police and traffic re-routed for a period of hours. PCSO Roberts reported that details had not been supplied to local officers. Councillor Eastty undertook to contact the Cheshire Fire and Rescue Service for further information:

Resolved,

- 1. the report be noted;
- 2. Councillor Eastty be thanked for his offer to seek further information on the incident.

C43 Borough Council business

Borough Councillors Dixon and Eastty reported on matters under consideration by the Borough Council relating to the parish and on issues that they had acted on for residents since the last meeting. (The Council noted that the reports related to the parish council area and not to the wider area of the Rixton and Woolston Borough Ward unless there was an issue of interest to Woolston).

Details of matters since the last meeting:

- Surgeries had been held at the Woolston Social Club, Manchester Road on dates advertised on Saturdays from 11am to 1 pm by Councillors Dixon and/or Eastty commencing in July. The Chairman had represented the council at the surgery. Dates of future meetings had been published.
- A complaint had been received from a resident who had questioned the frequency of Service 4. Members reported that representations had been made in the past to the bus operator to maintain this service and it was suggested that a meeting should first be held with the Managing Director of the company before requesting any rescheduling.
- Investigations were continuing regarding a complaint relating to Giant Hogweed at Juniper Lane.

Consideration was given to the procedure for reports from Borough Ward Councillors and it was requested that a written report be submitted from a Ward Councillor was unable to attend a meeting.

C44 Committee matters

(1) Environment and Amenities Committee

(a) Parish Path Warden scheme

Councillor Nowell reported on matters relating to public footpaths and on matters that had been reported to the Borough Council:

The path at Moss Brow was inaccessible because of the overgrown vegetation.
 The steps from Nicol Avenue to the path were covered in broken glass and blocked with vegetation.

Councillor J Greenslade requested details on the arrangements for the new definitive plan for public paths. Councillor Nowell understood that the closing date for submitting details of paths to be recorded was in 2026:

Resolved,

That the report be noted.

(b) Woolston Weir - Hydropol scheme

The Chairman of the Environment and Amenities Committee, Councillor J Greenslade, reported that:

Photographs and videos were available on the Woolston and Martinscroft Facebook site of some areas of the scheme, showing the turbine house, turbines and the new fish pass and the removal of pilings. A video clearly shows the screws in operation. Some members' comments refer to the noise of the screws, but there is assurance that they are not as noisy as the syphon weir.

The Chairman, having visited the site perimeter to see the reinstatement progress, reported that the Old Billy plaque was still buried under sheeting and hoped that it would be uncovered unscathed.

Although the protective barriers for cyclists and pedestrians have been removed, there was still a clutter of construction residue that needs to be cleared to ensure nothing is dragged out onto Weir Lane. This reinstatement should be in accordance with Hydropol's initial undertaking to the Council:

Resolved,

(c) Development of "old Billy" scheme

Further to Minute C31 (1)(b) 23 June 2021, the Council reviewed progress on the scheme. A site meeting was to be held with officers from the Borough Council and Culture Warrington to consider details of the scheme. This would allow the project to proceed in liaison with other councils and groups and for the bid to the National Lottery Heritage Fund to be prepared by the Borough Council:

Maintenance works had been recommended together with the timing of the next inspections. The Council noted that representations had been made by a resident relating to trees on the eastern side of the Green. No recommendations had been made relating to the representations made:

The Clerk reported that the Woolston Neighbourhood Hub was available for meetings following the changes in the national guidance on covid safety. Discussions were to be held with the management on the suitability of rooms at the centre for meetings:

- New Cut Heritage and Ecology Trail Group Councillor J Greenslade No meeting held because of covid guidance. Information published by the group on their website.
- Friends of Woolston Park report by Councillor Pearce:

30 June

Woolston 6th Form students visit had to be cancelled due to another commitment at the school.

7 July

Woolston 6th Form students and teachers came to work on the park again as part of their Duke of Edinburgh Award scheme. 12 people attended, 6 children and 4 teachers. After the initial meeting the children were given a choice of which team they preferred. One team worked with cutting/lopping equipment tidying overgrown branches from bushes close to the Cabin and car park. The other team voted for litter picking and covered a fair distance over the bridge by the pond working towards the Whitchurch estate going through the woods onto the Green Lane football grounds where there was a fair amount of litter. Everyone seemed to have a nice time.

10 July

Young Friends of Woolston Park (YFOWP) came for their monthly meeting. 12 people attended. They began with a short session of games before starting to do some jobs, they were split into 3 groups.

Group 1 collected seeds from cowslips and bluebells putting them into bags to dry off at home. They were given pots of soil for the seeds to take home and bring back at a later date. They also pruned the Cotoneasters by the cabin and pinned down some of the shoots onto the soil so they could root naturally and fill in some gaps.

Group 2 planted some good-sized cow-slip plants grown and provided by the Chairman around the meadow area close to Poulton Crescent and out of the way of any mowing down when the grass gets cut.

Group 3 cut back overgrown branches from bushes, nettles and undergrowth along by the pond and gazebo. The path now looks wider.

14 July

Woolston 6th Form students and teachers came again to work on the park as part of their Duke of Edinburgh's Award scheme.

The Chairman taught one group how to plant a mixture of seeds and how to treat them for planting out either at home or back in the park and afterwards they did another litter pick. The Vice Chairman took another group out to cut back branches and nettles along the footpath leading to the cabin and I showed some pupils how to safely thread string through a quantity of peanuts in their shells to hang up in the trees/bushes for the birds and wildlife so they can eat the nuts. One of the teachers later took some students to hang the stringed nuts around the area near the cabin.

At the end of their class the teachers and helpers had brought lunch for us all to sit and eat at the picnic area as it was their last day for the students who will be going on to college next term. The teachers and students had prepared the lunch at the school using some of their own produce that had been grown in the school grounds. The Vice Chairman presented each student with a small badge with the FOWP Kingfisher logo on it to each student. They all enjoyed the day and were sad that it was the last session on the park for most of them.

19 & 26 July

Work Day and AGM on 19 July was unfortunately cancelled due to some unforeseen circumstances until the 26 July.

The FOWP received 12 way-marker posts made of oak with their logo and a rubbing plate attached. The 12 posts are situated along a circular trail in the park. Each post has a different image of some of the wildlife creatures and leaves here in the park. A piece of paper can be placed over the image and rubbed with a pencil or crayon to achieve a print of the image to use for many interesting ideas especially for children. The posts were provided by Cheshire Community Foundation who have funded this project. These posts are very impressive and are much appreciated by the Friends and those who will use them in the future. Thank You Cheshire Community Foundation for your generosity. Hopefully too the YFOWP and the local schools will also benefit from these posts.

It was also the day the FOWP Chairman retired from his position of Chairman after many years' service. Fortunately, he's agreed to continue as a valued FOWP Volunteer. His last achievement as Chairman was to receive a donation of £250 from Greencore Food Enterprise to enable the FOWP to purchase paint for repainting the cabin. He thanked everybody for their time and effort they have put in the park to keep it nice and tidy. Alex

was thanked on behalf of everyone in the meeting for all he had achieved over the years for Woolston Park and his willingness to continue helping out.

Jon and Sarah both put their names forward for the position as Chairman. The election was done using a ballot box and label. Jon had the most votes and has now taken on the responsibility of Chairman. Other posts remain the same. Maureen as Secretary, Lynne as Treasurer. The members all agreed a note of thanks to Sarah for showing an interest.

The Essential Guide

The Friends were successful in receiving a full-page article printed free of charge in the local Essential Guide magazine this month. We hope this article will help to get more volunteers to join us in the near future. Our many thanks go to the Essential Guide staff for their efficiency and kindness.

2 August

Because of school holidays some of the YFOWP were able to come to the park. Some of the younger children went to try out the new way-marker posts which apparently are being well used and quite a talking point. Another group went litter picking and the rest worked near the pond erecting a lovely handmade trough on legs made by Tom one of the volunteers and then tidied up the surrounding area.

August was a quiet month with regard to other groups involvement in the park. However, much work has been achieved throughout the month with several of the regular Friends attending and I'm happy to say we have also got several new members who have already been involved this month.

The FOWP had a meeting on 20th, unfortunately I was unable to attend due to a friend's funeral. If there is anything of interest to the parish council, I will include it with next month's report.

6 September

Started the month off well with the regular friends plus 5 of the new members all happy doing a variety of the usual tasks, even the weather was good.

Woolston 6th Form new students will be attending the park on a regularly basis starting this month each Wednesday afternoon (15, 22, 29 Sept and 6 Oct).

Saturday 11 September is the return of the YFOWP.

- 4. A variation of condition should be imposed for a separate planning permission for the finished area to allow public representations for controlled public access rather than a plan for details of footpaths, hides etc as proposed.

- Dispersal Order was authorised on Woolston Park on 16 Aug for a 48h period after patrols repeatedly encountered large groups of teenagers gathering on the park who dispersed on seeing them, evidence of smashed glass and discarded alcohol, wheelie bins left out overnight on nearby roads had been taken onto the park (one was returned to the resident, although another had been burnt). Some teenagers present on the park have been identified, parents contacted. BTP contacted for awareness of groups arriving from Salford and across Warrington via the train network
- Woolston Park Bins fires and ASB Officers from across other areas of Warrington (including other beat areas, Response, Specials) have been supporting us with patrols of the park
